

Security, such as locking doors and closing windows, is one of the services that ESS provides for its customers. When entering your building, be aware if there is anyone in the building, lock the door behind you, and if there is an alarm, turn it off when you arrive and turn it back on when you leave. Always keep an eye on windows, and close and lock any that you find open. Leave all interior doors as you find them. Report any strange behavior to your manager immediately (such as someone hanging around outside the building).

Safety Violation Refresher

The following are examples of unsafe acts that can lead to accidents. Committing any of these acts is a safety violation. Please review them and make sure you avoid these unsafe acts.

Improper lifting Techniques. Lift with your legs and keep your back straight. Get help if the load is too heavy or divide your load.

Talking on a cell phone while working. Being distracted instead of focusing on the task at hand can lead to an accident.

Wearing a backpack vacuum incorrectly. Tighten and fasten all straps, belts and buckles.

Cleaning a restroom without gloves. This not only exposes your hands to chemical hazards, but it is also unsanitary.

Using a cleaning product that is not labeled or labeled incorrectly. Ask your manager for labels if you need them. Do not put a product into a spray bottle that is labeled for a different product.

Improper winding or pulling of electrical cords.

After use, wind the cord loosely. Unplug the cord by pulling the plug (not the cord) at the outlet.

Walking on ice outside a building. Apply ice melt to any path you walk on. Ice melt is available from ESS and the customer usually has a supply. Ice cleats can be made available.

Improper use of a ladder. We have dusters with extension handles for high dusting. There should not be any reason for getting on a ladder unless it is required of your specific jobsite and/or job duties (like changing light bulbs).

Allowing unauthorized people into a building.

This can be unsafe for you personally or for the customer or the customer's property.

Indulging in horseplay at work. While a core value of ESS Clean is to "Have Fun", do not get involved in horseplay.

Someone can get hurt!

Mopping without a "Caution: Wet Floor" sign.


Always use a sign, regardless of whether any people are in the building.

Improper footwear (i.e., Sandals). Do not wear open-toed or open-healed shoes. This could lead to foot injury or a mishap with chemicals.
